USLAW NETWORK ANNOUNCES 2012 CALENDAR OF NATIONAL CONFERENCES AND REGIONAL MEETINGS

CORAL SPRINGS, Florida (November 1, 2011) – USLAW NETWORK has announced its Meeting and Event Schedule for 2012.

Highlighting the year will be the Spring 2012 Client Conference scheduled for April 12 – 14 at the St. Regis Monarch Beach Hotel in Dana Point, California.
