

John F. Kennedy and the Memory of a Nation

On November 22, 1963, the Texas School Book Depository building was the focus of world shock, grief, and outrage when President John F. Kennedy was assassinated in Dealey Plaza. Evidence was found that shots were fired from this floor. Twenty-six years later, *John F. Kennedy and the Memory of a Nation* opened on Presidents' Day, February 20, 1989. This exhibit recreates the social and political context of the early 1960s, chronicles the assassination and its aftermath, and recognizes Kennedy's lasting impact on contemporary culture.
